By signing this, I hereby acknowledge and understand that the handling of animals and other volunteer activities have potential of placing me in a hazardous situation such as an injury or death, I willing understand that risk. In consideration of being allowed to participate in the Humane Society of Logan County activities and volunteering, I hereby release and hold HSLC harmless from any liability whatsoever arising from my participation, this includes any other volunteers, employees, and Board Members. However, I allow HSLC to seek emergency medical treatment on my behalf in case of an accident, injury, or illness. I certify that the information provided by me is accurate and true to the best of my knowledge. As a volunteer for HSLC, I understand that I may have access to confidential information which might not be generally known by or accessible by the public. I acknowledge that disclosure of confidential information is NOT permitted unless approved. Therefore, if I question that it is confidential, I MUST ask the Shelter Manager before spreading information. This shall apply and be binding during and after my time with HSLC.
